THE NEW HAVEN SOLID WASTE RECYCLING AUTHORITY (NHSWRA) GRANTS LICENSEE THE RIGHT TO DUMP AT THE AUTHORITY'S REFUSE DISPOSAL FACILITY, MIDDLETOWN AVENUE, SUBJECT TO THE FOLLOWING CONDITIONS, AS PER SECTION 16-8 OF THE CODE OF ORDINANCES OF THE CITY OF NEW HAVEN.

- a. REFUSE DUMPED AT THE REFUSE DISPOSAL FACILITY IS LIMITED TO EITHER REFUSE THAT HAS ORIGINATED WITHIN THE CITY LIMITS OF NEW HAVEN, OR HAS BEEN CONVEYED BY THE CITY'S CONTRACTUAL FACILITY OPERATOR OR ITS CUSTOMERS, AND SHALL IN ALL INSTANCES CONFORM TO CT STATE LAW.
- b. REFUSE MAY BE DUMPED ONLY BETWEEN 6:30 A.M. AND 3:00 P.M. MONDAY THROUGH FRIDAY, INCLUSIVE, NO DUMPING SHALL BE PERMITTED ON SATURDAY, SUNDAY OR LEGAL HOLIDAYS.
- c. LICENSEE SHALL NOT SALVAGE MATERIAL FROM THE REFUSE DISPOSAL FACILITY
- d. LICENSEE MUST OBTAIN AN ANNUAL PERMIT FROM THE AUTHORITY FOR EACH VEHICLE USING THE REFUSE DISPOSAL FACILITY
- e. LICENSEE SHALL PAY SUCH REFUSE DISPOSAL PER TON CHARGE AS IS ESTABLISHED BY THE NHSWRA
- f. VIOLATION OF ANY OF THE ABOVE PROVISIONS OF THIS LICENSE SHALL BE GROUNDS FOR IMMEDIATE SUSPENSION OR REVOCATION OF THIS LICENSE, SUBJECT TO REVIEW BY THE EXECUTIVE DIRECTOR OF THE AUTHORITY. IN ADDITION, VIOLATORS ARE SUBJECT TO A FINE OF NOT MORE THAN \$100.00 OR 30 DAYS IN JAIL, OR BOTH.
